In consideration of the Mono Tennis Club accepting the member(s) listed on this form for membership and participation in the Club:

I, being a member of the Mono Tennis Club, hereby for myself, my personal representatives, heirs and next of kin (hereinafter defined as the 'Releasers') agree to release, waive, discharge and agree not to sue the Mono Tennis Club, its directors, officers, members, employees and volunteers (hereinafter defined as the 'Releasees') from all liability to myself, my personal representatives, assigns, heirs and next of kin for any and all loss or damage, and any claim or demands therefore on account of injury to my person or property or resulting in my death, now and forever, arising out of or from participation in the said Mono Tennis Club on any of its related activities that may occur, whether caused by the negligence of the Releasees or otherwise.
